1 Name of Plan

This Plan is *Marrickville Local Environmental Plan 2011 (Amendment No 7)*.

2 Commencement

This Plan commences on the day on which it is published on the NSW legislation website.

3 Land to which Plan applies

This Plan applies to land to which *Marrickville Local Environmental Plan 2011* applies.

4 Maps

The maps adopted by *Marrickville Local Environmental Plan 2011* are amended or replaced, as the case requires, by the maps approved by the Greater Sydney Commission on the making of this Plan.

Schedule 1 Amendment of Marrickville Local Environmental Plan 2011

[1] Clause 1.2 Aims of Plan

Omit “Marrickville” from clause 1.2 (1).

Insert instead “that part of Inner West local government area to which this Plan applies (in this Plan referred to as *Marrickville*)”.

[2] Clause 6.5 Development in areas subject to aircraft noise

Omit “AS 2021–2000” and “AS 2021—2000” wherever occurring.

Insert instead “AS 2021:2015”.

[3] Schedule 1 Additional permitted uses

Omit “and Lot 2, DP 103507” from clause 9 (1).

Insert instead “, Lot 2, DP 103507 and Lots 36 and 37, DP 3164”.

[4] Schedule 1, clause 11, heading

Omit “36”. Insert instead “32–72”.

[5] Schedule 1, clause 11 (1)

Omit the subclause. Insert instead:

- (1) This clause applies to land at 32–72 Alice Street, Newtown, being Lots 2 and 3, DP 1190094 and SP 88894.

[6] Schedule 1, clause 18 (1)

Omit “Lots 20 and 22,”. Insert instead “Lots 20–22, Section B,”.

[7] Schedule 1, clause 21 (1)

Omit the subclause. Insert instead:

- (1) This clause applies to land at 1 Tramway Street, Tempe, being Lot 1, DP 925726 and 1B Gannon Street, Tempe (also known as 745–763 Princes Highway, Tempe), being part of Lot 1, DP 724918, and Lot 1710, DP 1140035.

[8] Schedule 5 Environmental heritage

Omit the matter relating to item no I27 from Part 1.

Insert the following in appropriate order:
