1 Name of Plan

This Plan is *Canterbury Local Environmental Plan 2012 (Amendment No 15)*.

2 Commencement

- (f) 1 Victa Street, Campsie (SP 90693),
- (g) 260A, 260 and 262 Canterbury Road, Canterbury (Lots 1 and 2, DP 1137357 and part of Lot 7018, DP 93382),
- (h) 2–4 Sugar House Road, Canterbury (SP 70958 and SP 80997),
- (i) 96A Moorefields Road, Kingsgrove (Lot 2, DP 594305),
- (j) 46 Fairmount Street, Lakemba (Lot 49, DP 6351),
- (k) 15 Wangee Road, Lakemba (Lot D, DP 312230),
- (l) 39 Ludgate Street, Roselands (Lot 4, DP 701311),
- (m) 102 and 102A Rogers Street, Roselands (Lot 1, DP 623244 and Lot B, DP 399441).

Omit “Mill” and “Lot 1437, DP 1015590”.

Insert instead “Works” and “SP 70958 and SP 80997”, respectively.

[6] Schedule 5, Part 1, item I140

Omit “Moorefields Methodist Cemetery” and “Lot 2”.

Insert instead “Moorfields Methodist Cemetery” and “Lot 2,”, respectively.
