1 Name of policy

This policy is State Environmental Planning Policy (Precincts—Regional) Amendment (Snowy Mountains Activation Precinct) 2023.

2 Commencement

This policy commences on the day on which it is published on the NSW legislation website.

This policy is repealed at the beginning of the day following the day on which this policy commences.
