His Excellency the Lieutenant-Governor, with the advice of the Executive Council, has made the following Regulation under the *Business Names Act 2002*.

#### **Explanatory note**

The object of this Regulation is to amend the *Business Names Regulation 2004* to increase certain fees payable in connection with the administration of the *Business Names Act 2002*. The fee increases are generally in line with movements in the Consumer Price Index (rounded to the nearest whole dollar).

This Regulation is made under the *Business Names Act 2002*, including sections 5 (Application to registration of *Licensing and Registration (Uniform Procedures) Act 2002*) and 40 (the general regulation-making power).
