Explanatory note

The object of this Regulation is to amend the *Property, Stock and Business Agents Regulation* 2003 to increase application fees for licences and certificates of registration and Compensation Fund contributions payable under the *Property, Stock and Business Agents Act* 2002. The fee and contribution increases are generally in line with movements in the Consumer Price Index (rounded to the nearest dollar).

This Regulation is made under the *Property, Stock and Business Agents Act 2002*, including sections 17 (Application to licences of *Licensing and Registration (Uniform Procedures) Act 2002*), 17A (Application fees and Compensation Fund contributions) and 230 (the general regulation-making power).
