Explanatory note

The object of this Regulation is to amend the *Travel Agents Regulation 2006* to increase licence application fees and other fees payable under the *Travel Agents Act 1986*. The fee increases are generally in line with movements in the Consumer Price Index (rounded to the nearest dollar).

This Regulation is made under the *Travel Agents Act 1986*, including sections 7A (Application to licences of *Licensing and Registration (Uniform Procedures) Act 2002*), 15 (Register of licensees), 17 (Annual fee and annual statement) and 57 (the general regulation-making power).
