#### 1 Name of Order

This Order is the Subordinate Legislation (Postponement of Repeal) Order 2013.

#### 2 Commencement

#### 3 Postponement of repeal of certain statutory rules

The repeal, by section 10 of the *Subordinate Legislation Act 1989*, of the statutory rules listed in Schedule 1 is postponed from 1 September 2013 to 1 September 2014.
