# Children and Young Persons (Care and Protection) Amendment Bill 2024

### **Explanatory note**

This explanatory note relates to this Bill as introduced into Parliament.

### Overview of Bill

The object of this Bill is to amend the *Children and Young Persons (Care and Protection) Act* 1998 to provide that the Act is intended to have extraterritorial application, including in relation to children and young persons who do not ordinarily live in, or who are not present in, New South Wales, if there is a sufficient connection to New South Wales.

## Outline of provisions

Clause 1 sets out the name, also called the short title, of the proposed Act.

Clause 2 provides for the commencement of the proposed Act.

## Schedule 1 Amendment of Children and Young Persons (Care and Protection) Act 1998 No 157

Schedule 1[1] and [2] give effect to the overview above. Schedule 1[3] provides for the application of the proposed Act.
