Miscellaneous Acts (Local Court) Amendment Act 2007 No 94

Act No 94, 2007

An Act to amend various Acts and instruments as a consequence of the proposed enactment of the *Local Court Act 2007*. [Assented to 13 December 2007]

The Legislature of New South Wales enacts:

1 Name of Act

This Act is the Miscellaneous Acts (Local Court) Amendment Act 2007.

2 Commencement

This Act commences on a day or days to be appointed by proclamation.

3 Amendment of Acts and instruments

The Acts and instruments specified in Schedule 1 are amended as set out in that Schedule.

4 Further amendment of Acts and instruments

- (1) Each Act and instrument specified in Column 1 of Schedule 2 is amended by omitting "a Local Court" wherever occurring in the provision of that Act or instrument specified in Column 2 of that Schedule and inserting instead "the Local Court".
- (2) Each Act and instrument specified in Column 1 of Schedule 3 is amended by omitting "A Local Court" wherever occurring in the provision of that Act or instrument specified in Column 2 of that Schedule and inserting instead "The Local Court".
- (3) Each Act and instrument specified in Column 1 of Schedule 4 is amended by omitting "a Local Court constituted by a Magistrate sitting alone" wherever occurring in the provision of that Act or instrument specified in Column 2 of that Schedule and inserting instead "the Local Court".
- (4) Each Act and instrument specified in Column 1 of Schedule 5 is amended by omitting "a Local Court constituted by a Magistrate" wherever occurring in the provision of that Act or instrument specified in Column 2 of that Schedule and inserting instead "the Local Court".
- (5) Each Act and instrument specified in Column 1 of Schedule 6 is amended by omitting "a Local Court held before a Magistrate sitting alone" wherever occurring in the provision of that Act or instrument specified in Column 2 of that Schedule and inserting instead "the Local Court".
- (6) Each Act and instrument specified in Column 1 of Schedule 7 is amended by omitting "Local Courts Act 1982" wherever occurring in the provision of that Act or instrument specified in Column 2 of that Schedule and inserting instead "Local Court Act 2007".

5 Repeal of Courts of Petty Sessions (Civil Claims) Further Amendment Act 1982 No 166

The Courts of Petty Sessions (Civil Claims) Further Amendment Act 1982 is repealed.

6 Repeal of Act

- (1) This Act is repealed on the day following the day on which all of the provisions of this Act have commenced.
- (2) The repeal of this Act does not, because of the operation of section 30 of the *Interpretation Act 1987*, affect any amendment made by this Act.
