Act No 13, 2020

An Act to amend the *Law Enforcement Conduct Commission Act 2016* in relation to the eligibility requirements for appointment of the Chief Commissioner and in relation to vacancy of offices and to amend the *Government Sector Employment Act 2013* with respect to statutory officers of the Law Enforcement Conduct Commission. [Assented to 23 June 2020]

The Legislature of New South Wales enacts—

1 Name of Act

This Act is the Law Enforcement Conduct Commission Amendment Act 2020.

2 Commencement

This Act commences on the date of assent to this Act.

17 Creation of vacancy

The removal from office of a member of the Commission, or an Assistant Commissioner, or an alternate Commissioner, under Part 6 of the *Government Sector Employment Act 2013* before the commencement of the *Law Enforcement Conduct Commission Amendment Act 2020* is taken to have created a vacancy in that office.
