## Explanatory note

The object of this Order is to amend the *Public Health (COVID-19 Restrictions on Gathering and Movement) Order (No 4) 2020* to provide for greater restrictions on gatherings in pubs.

## **Public Health (COVID-19 Restrictions on Gathering and Movement) Order (No 4) Amendment Order 2020**

Public Health Act 2010

### **1 Name of Order**

This Order is the *Public Health (COVID-19 Restrictions on Gathering and Movement) Order (No 4) Amendment Order 2020*.

### **2 Commencement**

- (1) This Order, other than Schedule 1[1], commences at the beginning of 17 July 2020.
- (2) Schedule 1[1] commences at the beginning of 18 July 2020.

## **Schedule 1      Amendment of Public Health (COVID-19 Restrictions on Gathering and Movement) Order (No 4)**

### **[1]    Clause 7 Direction of Minister requiring COVID-19 Safety Plans**

Insert at the end of clause 7—

- (2)    The Minister directs that if the premises are a pub, the occupier of the pub must ensure the COVID-19 Safety Plan for the pub is registered with the NSW Government.

### **[2]    Clause 8 Direction of Minister about number of persons allowed on premises**

Insert after clause 8(2)(a)—

- (ab)    a pub, or

### **[3]    Clause 8A**

Insert after clause 8—

#### **8A    Direction of Minister about pubs**

- (1)    The Minister directs that the occupier of a pub must ensure that the maximum number of persons on the premises is the lesser of—
- (a)    the number of persons that is equivalent to one person per 4 square metres of space in the premises, or
- (b)    300 persons.
- (2)    The Minister directs that the occupier of the pub must ensure that—
- (a)    no individual group entering or on the premises consists of more than 10 persons, and
- (b)    an individual booking or reservation for a group entering or on the premises does not consist of more than 10 persons.

### **[4]    Clause 22 Directions of Minister concerning persons providing contact details**

Omit clause 22(2)(a). Insert instead—

- (a)    for premises that are a pub—require the person to provide the person’s contact details, and
- (ab)    for any other premises—require the person to provide the person’s contact details unless—
- (i)    the person is a member of a discrete group of persons who are attending the premises together, and
- (ii)    the occupier obtains contact details from one adult member of the group (for example, a person who makes a booking or reservation), and

### **[5]    Clause 22(3)**

Omit “subclause (2)(a)(ii)”. Insert instead “subclause (2)(ab)(ii)”.
