Commencement

1. This Regulation commences on 23 December 1994.

Amendment

2. The Maritime (Short Description of Offences) Regulation 1987 is amended by inserting in Columns 1 and 2 of Schedule 1 after the matter relating to Regulation 6 (4) of the Water Traffic Regulations—N.S.W. the following matter:

Regulation 6 (6) (a)— navigate personal water craft towing a water skier or aquaplaner in a designated surf zone within 100 m of person in the water	navigate water craft towing skier or aquaplaner near person

Regulation 6 (6) (b)— navigate personal water craft towing a water skier or aquaplaner in a designated surf zone within 100 m of vessel	navigate water craft towing skier or aquaplaner near vessel

Regulation 6 (6) (b)— navigate personal water craft towing a water skier or aquaplaner in a designated surf zone within 100m of property	navigate water craft towing skier or aquaplaner near property
Regulation 6 (6) (c)— navigate personal water craft towing a water skier or aquaplaner in a designated surf zone within 100m of shore	navigate water craft towing skier or aquaplaner near shore
Regulation 14 (13A)—being the owner of a personal water craft driven by an unlicensed driver at a speed of or exceeding 10 knots on navigable waters	own water craft driven at speed by unlicensed driver
Regulation 14 (13B)—being the unlicensed driver of a personal water craft driven at a speed of or exceeding 10 knots on navigable waters	drive water craft at speed while unlicensed
Regulation 15 (4) (a)— navigate personal water craft in a designated surf zone at a speed of or exceeding 10 knots within 100 m of person in the water	navigate water craft at speed near person
Regulation 15 (4) (b)— navigate personal water craft in a designated surf zone at a speed of or exceeding 10 knots within 100m of vessel	navigate water craft at speed near vessel

Regulation 15 (4) (b)— navigate personal water craft in a designated surf zone at a speed of or exceeding 10 knots within 100 m of property	navigate water craft at speed near property
Regulation 15 (4) (c)— navigate personal water craft in a designated surf zone at a speed of or exceeding 10 knots within 100 m of shore	navigate water craft at speed near shore
Regulation 15A (1) (a)— being the owner of a personal water craft without a behaviour sticker affixed as required by Regulation 15A (2)	own personal water craft without behaviour sticker affixed
Regulation 15A (1) (b)— being the owner of a personal water craft with a behaviour sticker affixed which is defaced	own personal water craft with behaviour sticker defaced
Regulation 15A (1) (b)— being the owner of a personal water craft with a behaviour sticker affixed which is obliterated	own personal water craft with behaviour sticker obliterated
Regulation 15A (1) (b)— being the owner of a personal water craft with a behaviour sticker affixed which is concealed	own personal water craft with behaviour sticker concealed
Regulation 15A (3)—drive a personal water craft in contravention of the requirements of the behaviour sticker	drive water craft in contravention of behaviour sticker

EXPLANATORY NOTE

This Regulation prescribes the short descriptions that, under section 145B of the Justices Act 1902, are sufficient to state or describe, in any information, complaint, summons, warrant, notice, order or other document, certain offences under the Water Traffic Regulations—N.S.W. relating to the use of personal water craft.

This Regulation is made under the Justices Act 1902, including section 154 (the general regulation making power) and section 145B.
