

**FACTORIES, SHOPS AND INDUSTRIES ACT 1962—  
REGULATION**

(Relating to boiler and pressure vessel inspection fees)

NEW SOUTH WALES

HIS Excellency the Governor, with the advice of the Executive Council, and in pursuance of the Factories, Shops and Industries Act 1962, has been pleased to make the Regulation set forth hereunder.

**Commencement**

1. This Regulation commences on 13 February 1995.

**Amendment**

2. The Boiler and Pressure Vessel Regulations are amended by omitting item 1 of Schedule 1 and by inserting instead the following item:

1. *Fees to be charged by boiler inspectors*

The fees referred to in Regulation 34 are as follows:

- (a) Locomotive, traction engine or road roller boiler:

(iv) exceeding 15 square metres but not exceeding 70 square metres .....	\$106.00
(v) exceeding 70 square metres but not exceeding 200 square metres .....	\$140.00
(vi) exceeding 200 square metres but not exceeding 400 square metres .....	\$184.00
(vii) exceeding 400 square metres but not exceeding 800 square metres .....	\$184.00 plus \$6.30 per 100 square metres or part of 100 square metres of heating surface in excess of 400 square metres
(viii) exceeding 800 square metres .....	\$209.00 plus \$2.80 per 100 square metres or part of 100 square metres of heating surface in excess of 800 square metres
(c) Steam jacketed pan:	
(i) having an internal diameter not exceeding 1 metre	\$24.00
(ii) having an internal diameter exceeding 1 metre but not exceeding 1.5 metres .....	\$30.00
(iii) having an internal diameter exceeding 1.5 metres .	\$36.00
(d) Pressure vessel (other than a steam jacketed pan) having an internal cubic capacity:	
(i) not exceeding 50 litres .....	\$24.00
(ii) exceeding 50 litres but not exceeding 1 500 litres	\$30.00
(iii) exceeding 1 500 litres but not exceeding 2 500 litres .....	\$48.00
(iv) exceeding 2 500 litres but not exceeding 15 000 litres .....	\$72.00

(v) exceeding 15 000 litres but not exceeding 700 000 litres .....	\$72.00 plus \$2.20 per 2 500 litres or part of 2 500 litres in excess of 15 000 litres
(vi) exceeding 700 000 litres .....	\$672.00 plus \$2.20 per 25 000 litres or part of 25 000 litres in excess of 700 000 litres

A 50 per cent surcharge applies for the inspection of a digester, dry renderer, melter, blood receiver, blood dryer or expeller trough.

**(e) Surcharge for single inspection:**

Despite any other provision of this item, a 50 per cent surcharge applies if on any one day:

- (i) only one boiler (and no pressure vessel) or only one pressure vessel (and no boiler) located on any particular premises is inspected; and
- (ii) the boiler or pressure vessel is of a kind referred to in paragraph (b) (i), (c) (i), (c) (ii), (d) (i) or (d) (ii).

**(f) Discount for multiple inspections:**

Despite any other provision of this item, if on any one day 5 or more boilers, or 5 or more pressure vessels, located on the same premises are inspected, a 20 per cent discount applies.

**(g) Additional fee for pipe system inspection:**

An additional fee of \$38.00 per hour or part of an hour is to be charged for the inspection of:

- (i) a steam pipe system used in connection with a boiler; or
- (ii) connecting pipes subject to corrosion and wastage and used in connection with a refrigeration system.

**(h) Surcharge for inspection on Saturday, Sunday or public holiday:**

If the owner of a boiler or pressure vessel specifically requests that an inspection of the boiler or pressure vessel be made on a Saturday, Sunday or public holiday, the fee to be charged for an inspection made on that day is double the fee that is otherwise applicable.

- (i) Certificates of inspection—Forms B.R.3 and B.R.4 ..... \$1.60

**EXPLANATORY NOTE**

This Regulation increases the fees for inspecting boilers and pressure vessels. Those fees were last increased early in 1991.

This Regulation is made under the Factories, Shops and Industries Act 1962 and in particular section 65 (Power to make regulations), for example section 65 (1) (h) and (i).
