# LOCAL GOVERNMENT (ELECTIONS) ACT.

# Act No. 39, 1940.

George VI. No. 89, 1940.

An Act to provide for the postponement of certain elections of aldermen and councillors of municipalities and shires and of aldermen of the City of Sydney; to validate certain matters; to amend the Local Government Act, 1919, the Sydney Corporation Act, 1932-1940, and certain other Acts in certain respects; and for purposes connected therewith. [Assented to, 29th November, 1940.]

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

# Preliminary.

Short title and division into Parts. 1. (1) This Act may be cited as the "Local Government (Elections) Act, 1940."

#### PART II.

AMENDMENTS OF LOCAL GOVERNMENT ACT, 1919.

2. (1) This Part shall be read and construed with the Construc-Local Government Act, 1919, as amended by subsequent Acts.

- (2) The Local Government Act, 1919, as so amended, is in this Part referred to as the Principal Act.
- 3. Time for election of mayor or president.

(3) Notwithstanding the postponement by this Part of this Act of the ordinary election of aldermen and councillors, an ordinary election of mayor or president shall be held in each area during the month of December, one thousand nine hundred and forty.

Non-preparation of rolls.

- (4) (a) Notwithstanding the provisions of section sixty-four of the Principal Act it shall not be necessary for a council to prepare in the year one thousand nine hundred and forty an original or a supplementary roll of electors.
- (b) This subsection shall be deemed to have commenced on the first day of July, one thousand nine hundred and forty.
