George VI. An Act to amend the Roman Catholic Church Communities' Lands Act, 1942, in certain respects; and for purposes connected therewith. [Assented to, 15th December, 1943.]

B^E it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

Short title and citation.

- 1. (1) This Act may be cited as the "Roman Catholic Church Communities' Lands (Amendment) Act, 1943."
- (2) The Roman Catholic Church Communities' Lands Act, 1942, as amended by this Act, may be cited as the Roman Catholic Church Communities' Lands Act, 1942-1943.

- (a) by inserting in section two at the end of the Sec. 2. definition of "Community" the following new (Definitions.) paragraphs:—

- (c) by inserting at the end of section eight the Sec. 8. following new subsection:—
 - (3) Subsections one and two of this section communities' shall, in their application to and in respect of land.) the communities referred to in paragraphs (xix) and (xx) of the definition of "Community" and the community lands of those communities, have and take effect as on and from the commencement of the Roman Catholic Church Communities' Lands (Amendment) Act, 1943; and for the purposes of such application the reference in subsection two of this section to the "commencement of this Act" shall be read and construed as a reference to the "commencement of the Roman Catholic Church Communities' Lands (Amendment) Act, 1943."
- (d) (i) by inserting in paragraph (b) of subsection Sec. 10. one of section ten after the word "it" where (Powers of firstly occurring the words "or in relation bodies corporate). to any other land (being land, situated outside New South Wales, for the time being subject to any trust created before or after

the commencement of this Act, or after the commencement of the Roman Catholic Church Communities' Lands (Amendment) Act, 1943, for a community or for the use or benefit or for any purpose of a community) at any time vested in it';

(ii) by inserting in subparagraph (i) of the same paragraph after the words "community land" the words "or other land."
