#### 1 Name of plan

This plan is Warringah Local Environmental Plan 2000 (Amendment No 16).

#### 2 Aim of plan

The aim of this plan is:

- (a) to remove the public open space identification from certain land to which *Warringah Local Environmental Plan 2000* applies, and identify it differently, and
- (b) to identify certain other land to which that plan applies as public open space.
