[1] Land Use Table

Omit "Home occupations" wherever occurring in item 2 in the matter relating to Zones B3, B5, IN1, IN2, IN3, SP1 and SP2.

Insert instead "Nil".

[2] Land Use Table, Zone B6

Insert "Serviced apartments;" after "Service stations;" in item 3.

[3] Land Use Table, Zone RE2

Insert "Hotel or motel accommodation;" after "Function centres;" in item 3.

[4] Land Use Table, Zones E2 and W1

Omit "; Home occupations" wherever occurring in item 2.

[5] Land Use Table, Zone E3

Insert "Home-based child care;" after "Environmental protection works" in item 2.

[6] Clause 5.1 Relevant acquisition authority

Insert in appropriate order in the table to clause 5.1 (2) under the columns headed "Type of land shown on Map" and "Authority of the State", respectively:

Zone SP2 Infrastructure and marked Department of Education and "Educational establishment" Training

[7] Clause 7.13 Minimum lot width in Zones R1, R2, R3 and R4

Omit subclause (4). Insert instead:

- (4) If a lot resulting from a subdivision of land to which this clause applies is a battle-axe lot:
 - (a) the lot must have an average width of more than 10 metres and a minimum width of at least 5 metres, and
 - (b) the access handle must not be included when calculating the size of the lot for the purposes of clause 4.1 (3).

[8] Clause 7.13 (6)

Insert after clause 7.13 (5):

(6) In this clause, *battle-axe lot* means a lot that has access to a road by an access handle.

[9] Clause 7.16 Ground floor development in Zones B1, B2 and B4

Omit clause 7.16 (2). Insert instead:

(2) This clause applies to land in Zone B1 Neighbourhood Centre, B2 Local Centre or B4 Mixed Use.

[10] Clause 7.22 Development in Zone B6

Insert at the end of clause 7.22 (1) (b):

, and

(c) to ensure active uses are provided at street level to encourage the presence and movement of people.

[11] Clause 7.22 (6)

Insert after clause 7.22 (5):

(6) Development consent must not be granted for development for the purposes of a building on land to which this clause applies that is within 50 metres of a classified road unless the consent authority is satisfied that the ground floor of the building will have at least one entrance and at least one other door or window on the front of the building facing a street other than a service lane.
