1 Name of Plan

This Plan is Sutherland Shire Local Environmental Plan 2006 (Amendment No 9).

2 Commencement

3 Land to which Plan applies

This Plan applies to the land to which *Sutherland Shire Local Environmental Plan 2006* applies and, in particular, to the following land:
