1 Name of Plan

This Plan is Sutherland Shire Local Environmental Plan 2006 (Amendment No 12).

2 Commencement

This Plan commences on the day on which it is published on the NSW legislation website.

3 Land to which Plan applies

This Plan applies to the land to which Sutherland Shire Local Environmental Plan 2006 applies.

Schedule 1 Amendment to Sutherland Shire Local **Environmental Plan 2006**

Clause 14 Exceptions to Zoning Table—specified development on [1] specified land

Insert at the end of the Table to clause 14 (1) in Columns 1, 2 and 3 respectively:

97 Soldiers Road, Jannali Villa houses or

townhouses

The development must not result in a floor space ratio greater than 0.45:1.

[2] Clause 35 Building density

Insert "and (in relation to land at 97 Soldiers Road, Januali) clause 14 (1)" after "this clause" in clause 35 (4).

Clause 35 (5A) [3]

Insert after clause 35 (5):

The maximum gross floor area of all buildings at 97 Soldiers Road, Januali may exceed the area provided for in subclause (5), but only if the proposed development is for the purpose of villa houses or townhouses.

> Note. See clause 14 (1) for the maximum floor space ratio applying in relation to that development.
