1 Name of Policy

This Policy is State Environmental Planning Policy Amendment (Concurrence and Referrals) 2020.

1.1 Blue Mountains Local Environmental Plan 1991

Schedule 1 Development for additional purposes

Omit paragraph (a) from the matter relating to "Lots 12–19, 22–25 and 39–48, DP 7047 and Lot 8, DP 30397 Herbert Street, Leura".

1.2 Blue Mountains Local Environmental Plan 2005

Clauses 94(2) and 117(2)(i)

Omit the provisions.

1.3 Lithgow City Local Environmental Plan 1994

Clause 38A Habitat of Purple Copper Butterfly

Omit the clause.

1.4 Liverpool Local Environmental Plan 2008

Clause 7.7 Acid sulfate soils

Omit clause 7.7(3). Insert instead—

(3) Development consent must not be granted under this clause for the carrying out of works unless an acid sulfate soils management plan has been prepared for the proposed works in accordance with the *Acid Sulfate Soils Manual* and has been provided to the consent authority.

Omit Part 8.

[2] Schedule 7 MetroWest Investigation Area

Omit the Schedule.

Omit clause 24(1).

Omit "the Director-General of the Department of Services, Technology and Administration and" from clause 27(a).

Omit "their". Insert instead "the Commissioner's".

Omit clause 8. Insert instead—

8 Agricultural buffers

Consent must not be granted to development on land within an agricultural buffer unless the consent authority has considered the potential impact of the proposed development on agricultural activities on land adjoining the buffer and of those agricultural activities on future occupiers of land within the buffer.

Omit the definition of *the map*. Insert instead—

the map means the map marked "Sydney Regional Environmental Plan No 9—Extractive Industry (No 2)" published on the NSW planning portal.

[2] Clause 17 Development control codes

Omit clause 17(2).

[3] Schedule 1

Omit "held in the head office of the Department of Urban Affairs and Planning, Mount White, Central Coast (Sandstone)" from item 7 in Division 9.

Insert instead "published on the NSW planning portal".

3.3 Sydney Regional Environmental Plan No 24—Homebush Bay Area

[1] Clause 14 Consultation with other public bodies

Omit the clause.

[2] Clause 20A Acid sulfate soils

Omit "and" from clause 20A(2)(b) and omit clause 20A(2)(c).
