#### **Explanatory note**

The object of this Regulation is to increase the fees prescribed in Schedule 1 to the *Higher Education Regulation 2008*. The increases are in line with movements in the Labour Price Index with respect to the public sector.

This Regulation is made under the *Higher Education Act 2001*, including section 25 (the general regulation-making power).
