

Co-operative Housing and Starr-Bowkett Societies Amendment (Fees) Regulation 2009

Her Excellency the Governor, with the advice of the Executive Council, has made the following Regulation under the *Co-operative Housing and Starr-Bowkett Societies Act 1998*.

Explanatory note

The object of this Regulation is to amend the *Co-operative Housing and Starr-Bowkett Societies Regulation 2005*:

- (a) to increase certain fees payable in connection with the administration of the *Co-operative Housing and Starr-Bowkett Societies Act 1998*, and
- (b) to remove a fee relating to the inspection of a managing controller's report consequent on the repeal of section 421A (3) of the *Corporations Act 2001* of the Commonwealth.

The fee increases are generally in line with movements in the Consumer Price Index (rounded to the nearest dollar).

This Regulation is made under the *Co-operative Housing and Starr-Bowkett Societies Act* 1998, including sections 23 (1) and 225 (the general regulation-making power) and, in particular, section 225 (1A).
