Explanatory note

The object of this Regulation is to increase certain fees payable under the *Road Transport* (*Driver Licensing*) Act 1998.

The fee increases are generally in line with movements in the Consumer Price Index.

This Regulation is made under the *Road Transport (Driver Licensing) Act 1998*, including sections 19 (the general regulation-making power) and 20 (2) (f).
