Explanatory note

The object of this Regulation is to increase certain fees and deposits payable under the *Surveying and Spatial Information Act 2002*. The increases are generally in line with movements in the Consumer Price Index.

This Regulation is made under the *Surveying and Spatial Information Act 2002*, including section 36 (the general regulation-making power) and, in particular, section 36 (2) (j).
