Explanatory note

The object of this Regulation is to amend the Civil Procedure Regulation 2012:

- (a) to increase the fees payable in relation to civil proceedings generally and other fees that are payable to the Sheriff, and
- (b) to introduce new fees for:
 - (i) conducting a civil litigation search—\$42 (standard fee) and \$84 (corporation fee) for each name of a company or an individual searched against court records, and
 - (ii) amending on the NSW Online Registry website any document—\$18 for each document amended, and
 - (iii) conducting a debt search on a judgment debt registered with the Sheriff's office for enforcement—\$59 for each name of a company or an individual searched.

This Regulation is made under the Civil Procedure Act 2005, including section 18 (Fees).
