## Administrative Arrangements (Administration of Acts— Amendment No 7) Order 2018

under the

Constitution Act 1902

#### 1 Name of Order

This Order is the Administrative Arrangements (Administration of Acts—Amendment No 7) Order 2018.

#### 2 Commencement

- (1) This Order commences on the day on which it is published on the NSW legislation website, except as provided by subclause (2).
- (2) Schedule 2 commences on 8 January 2019.

#### 3 Allocation of the administration of Acts

- (1) The administration of the Acts listed in Schedule 1 are allocated to the Ministers indicated in that Schedule.
- (2) The administration of Acts or parts of Acts that directly amend other Acts are allocated to the Ministers administering the Act amended.
- (3) The allocations made by this Order replace any previous allocations of the Acts concerned that are inconsistent with the allocations made by this Order. Note. See section 15 of the *Interpretation Act 1987* for the interpretation of references to "the Minister" in an Act.
