

# Motor Accidents (Lifetime Care and Support) Regulation 2020

under the

Motor Accidents (Lifetime Care and Support) Act 2006

Her Excellency the Governor, with the advice of the Executive Council, has made the following Regulation under the *Motor Accidents (Lifetime Care and Support) Act 2006*.

#### **Explanatory note**

The object of this Regulation is to repeal and remake, without any substantial changes, the *Motor Accidents* (*Lifetime Care and Support*) Regulation 2015 which would otherwise be repealed on 1 September 2020 by section 10(2) of the *Subordinate Legislation Act 1989*.

This Regulation makes provision for the following—

- (a) to authorise the appointed directors of the board of Insurance and Care NSW as a class of persons to whom the Lifetime Care and Support Authority of New South Wales may delegate its functions under paragraph (b) of the definition of *authorised person* in section 41(2) of the *Motor Accidents* (Lifetime Care and Support) Act 2006 (the Act),
- (b) to prescribe the *Lifetime Care and Support (Catastrophic Injuries) Act 2014* of the Australian Capital Territory as a care and support scheme for the purposes of section 43A of the Act.

This Regulation is made under the *Motor Accidents (Lifetime Care and Support) Act 2006*, including paragraph (b) of the definition of *authorised person* in section 41(2), sections 43A and 63 (the general regulation-making power).

This Regulation comprises or relates to matters set out in Schedule 3 to the *Subordinate Legislation Act* 1989, namely matters of a machinery nature and matters that are not likely to impose an appreciable burden, cost or disadvantage on any sector of the public.

### Motor Accidents (Lifetime Care and Support) Regulation 2020

Motor Accidents (Lifetime Care and Support) Act 2006

#### 1 Name of Regulation

This Regulation is the *Motor Accidents (Lifetime Care and Support) Regulation* 2020.

#### 2 Commencement

This Regulation commences on the day on which it is published on the NSW legislation website.

**Note.** This Regulation repeals and replaces the *Motor Accidents (Lifetime Care and Support)* Regulation 2015, which would otherwise be repealed on 1 September 2020 by section 10(2) of the *Subordinate Legislation Act* 1989.

#### 3 Definition

In this Regulation—

the Act means the Motor Accidents (Lifetime Care and Support) Act 2006.

**Note.** The Act and the *Interpretation Act 1987* contain definitions and other provisions that affect the interpretation and application of this Regulation.

(2) Notes included in this Regulation do not form part of this Regulation.

#### 4 Delegation to authorised persons

The appointed directors of the ICNSW Board (within the meaning of the *State Insurance and Care Governance Act 2015*) are authorised as a class of persons for the purposes of section 41 of the Act.

#### 5 Other care and support scheme

The Lifetime Care and Support (Catastrophic Injuries) Act 2014 of the Australian Capital Territory is prescribed as a care and support scheme for the purposes of section 43A of the Act.

#### 6 Repeal and savings

- (1) The Motor Accidents (Lifetime Care and Support) Regulation 2015 is repealed.
- (2) Any act, matter or thing that, immediately before the repeal of the *Motor Accidents* (*Lifetime Care and Support*) Regulation 2015, had effect under that Regulation continues to have effect under this Regulation.
