

Biosecurity Order (Permitted Activities) Amendment Order 2020 (No. 2)

under the

Biosecurity Act 2015

I, Satendra Kumar, Director Plant Biosecurity and Product Integrity, Department of Primary Industries Biosecurity & Food Safety, Regional NSW, with the delegated authority of the Secretary of Regional NSW under section 379 of the *Biosecurity Act 2015* and pursuant to section 404A of the *Biosecurity Act 2015* ("the Act"), make the following Order.

Explanatory note

This Order is made under section 404A of the Act and section 43(2) of the *Interpretation Act 1987*.

The object of this Order is to amend the Biosecurity Order (Permitted Activities) 2019 to-

- (a) remove the requirement that a potted plant be treated in the period starting 28 days before dispatch and importation into the State,
- (b) remove the requirement that turf and potted plants be inspected and found to be free of tramp ants before importation into the State,
- (c) no longer allow a person to import a potted plant if dealt with in accordance with ICA scheme procedure ICA-40 "Property Freedom of Plants for Red Imported Fire Ant",
- (d) no longer allow a person to import a potted plant under the property freedom option in ECCPRIFA03.

This Order should be read in conjunction with the mandatory measures and regulatory measures contained in Part 2 of the *Biosecurity Regulation 2017*.

1 Name of Order

This Order is the Biosecurity Order (Permitted Activities) Amendment Order 2020 (No. 2).

2 Commencement

This Order commences on 2 November 2020.

3 Amendments to the Biosecurity Order (Permitted Activities) 2019

[1] Clause 89(1)(a)

Omit the words "in the period starting 28 days", and add after the word "dispatch," the words "the potting media that is part of".

[2] Clause 89(1)(b)

Omit sub-clause.

[3] Clause 89(1)(c)

Omit the words "and inspection".

[4] Clause 89(2)

Omit sub-clause.

[5] Clause 89(3)

Omit sub-clause.

[6] Clause 89

Add a new subclause "(1)(e)", as follows:

"the APVMA approved chemical used to treat the potting media for the potted plant remains efficacious until the potted plant arrives in New South Wales".

[7] Clause 89(1)

In the second line, replace "(d)" with "(e)".

[8] Clause 89(4)(b)

After the word "grown" in the first line, add the words "or re-potted".

[9] Clause 90

Omit clause.

[10] Clause 91(d)

Omit sub-clause.
