

Liquor Amendment (Liquor Licence Freeze) Regulation 2020

under the

Liquor Act 2007

Her Excellency the Governor, with the advice of the Executive Council, has made the following Regulation under the *Liquor Act 2007*.

Explanatory note

The objects of this Regulation are—

- (a) to extend the temporary freeze on licences and other authorisations in prescribed precincts from 1 December 2020 to 30 April 2021, and
- (b) to enable certain hotels and clubs to trade during extended hours for the following special events that will be held from December 2020 to October 2021—
 - (i) Dettol T20 International Cricket Series—Australia v India,
 - (ii) Australian Open Tennis Men's and Women's Fourth Round,
 - (iii) Australian Open Tennis Men's Singles Final,
 - (iv) Coonamble Rodeo and Campdraft,
 - (v) Vivid Sydney,
 - (vi) NRL Grand Final,
 - (vii) Bathurst 1000.

This Regulation is made under the *Liquor Act 2007*, including sections 13, 47A and 159 (the general regulation-making power).

1 Name of Regulation
