Explanatory note

The object of this Order is to declare, for the purpose of calculating certain payments under the *Workers Compensation Act 1987*, the *Workplace Injury Management and Workers Compensation Act 1998* and the *Workers' Compensation (Dust Diseases) Act 1942*—

- (a) in relation to the adjustment date of 1 October 2021—
 - (i) the latest index number, and
 - (ii) the amount at which each adjustable amount is to be construed, and
- (b) in relation to the review date of 1 October 2021—
 - (i) the number that equates to the factor $\frac{B}{C}$ for the purposes of the variation of a weekly payment, and
 - (ii) the amount that is to apply as the amount specified in the Workers Compensation Act 1987, section 38 A
