1 Name of Notice

This Notice is the *Electoral Funding (Adjustable Amounts) (Administrative and New Party Policy Development Funding) Notice* 2021.

2 Definition

In this Notice—

the Act means the Electoral Funding Act 2018.

3 Annual adjustment for inflation

For the purposes of clause 5(6) of Schedule 1 to the Act, the adjustable amounts that are to apply for a financial year set out in Schedule 1 are the amounts specified in the Schedule.
