

# Electoral Funding (Adjustable Amounts) (Electoral Expenditure) Notice 2024

under the

Electoral Funding Act 2018

### 1 Name of Notice

This Notice is the *Electoral Funding* (*Adjustable Amounts*) (*Electoral Expenditure*) Notice 2024.

#### 2 Definition

In this Notice *the Act* means the *Electoral Funding Act 2018*.

#### 3 Adjustment for inflation

For the purposes of clause 3(1) of Schedule 1 to the Act, the adjustable amounts that are to apply for a subsequent election period set out in Schedule 1 are the amounts specified in the Schedule.

## Schedule 1 Electoral expenditure caps

- 1 Adjustment--applicable caps on electoral expenditure for local government election campaigns: section 31 of the Act
  - (1) Candidates and groups (other than groups including mayoral candidates): section 31(3) of the Act
    - (a) where the number of enrolled electors for the local government area or ward concerned for the election is 5,000 or fewer: section 31(3)(a) of the Act

First day of election period	Adjustable amount
5 December 2021	\$6,600

(b) where the number of enrolled electors for the local government area or ward concerned for the election is more than 5,000 but fewer than 10,001: section 31(3)(b) of the Act

First day of election period	Adjustable amount
5 December 2021	\$11,000

(c) where the number of enrolled electors for the local government area or ward concerned for the election is more than 10,000 but fewer than 20,001: section 31(3)(c) of the Act

First day of election period	Adjustable amount
5 December 2021	\$19,800

(d) where the number of enrolled electors for the local government area or ward concerned for the election is more than 20,000 but fewer than 30,001: section 31(3)(d) of the Act

First day of election period	Adjustable amount
5 December 2021	\$27,500

(e) where the number of enrolled electors for the local government area or ward concerned for the election is more than 30,000 but fewer than 50,001: section 31(3)(e) of the Act

First day of election period	Adjustable amount
5 December 2021	\$39,600

(f) where the number of enrolled electors for the local government area or ward concerned for the election is more than 50,000 but fewer than 75,001: section 31(3)(f) of the Act

First day of election period	Adjustable amount
5 December 2021	\$50,600

(g) where the number of enrolled electors for the local government area or ward concerned for the election is more than 75,000 but fewer than 125,001: section 31(3)(g) of the Act

First day of election period	Adjustable amount
5 December 2021	\$69,900

(h) where the number of enrolled electors for the local government area or ward concerned for the election is more than 125,000: section 31(3)(h) of the Act

First day of election period	Adjustable amount
5 December 2021	\$79,200

(2) Maximum campaign office expenditure not included in electoral expenditure cap: section 7(4B) of the Act

First day of election period	Adjustable amount

Note-

The limit to the exemption of the expenditure cap at Section 7(4B) of the Act relating to campaign office expenditure is not included in this Notice as it was introduced after the commencement of the local government election period starting 5 December 2021 and is therefore not to be indexed for that local government election period.
