

Justice Legislation Amendment (Penalty Notices) Regulation 2024

His Excellency the Lieutenant-Governor, with the advice of the Executive Council, has made the following regulation under the *Criminal Procedure Act 1986* and the *Fines Act 1996*.

Explanatory note

The objects of this regulation are to—

- (a) amend the Criminal Procedure Regulation 2017 to prescribe certain offences under the Drug Misuse and Trafficking Act 1985 as penalty notice offences, and
- (b) amend the *Fines Regulation 2020* to provide that certain penalty notices issued under the *Drug Misuse and Trafficking Act 1985* are taken to be paid if the person to whom the notice is issued completes the drug health intervention under the Early Drug Diversion Initiative provided by, or on behalf of, NSW Health.

This regulation is made under the following provisions—

- (a) the Criminal Procedure Act 1986, sections 336 and 337,
- (b) the *Fines Act 1996*, section 23B(1)(b).

1 Name of regulation

This regulation is the *Justice Legislation Amendment (Penalty Notices) Regulation* 2024.

2 Commencement

This regulation commences on 29 February 2024.

traffickable quantity has the same meaning as in the Drug Misuse and Trafficking Act 1985.

Omit the matter relating to **Offences under** *Drug Misuse and Trafficking Act 1985* in the table to the clause.

Insert instead—

Offences under Drug Misuse and Trafficking Act 1985

Section 10— \$400

(a) for

3,4-Methylenedioxymethylamphetamine

- (i) in tablet form—is less than a traffickable quantity, or
- (ii) in another form—does not exceed a small quantity, or
- (b) for another drug other than cannabis leaf—does not exceed a small quantity.

Schedule 2 Amendment of Fines Regulation 2020

[1] Clause 7B

Insert after clause 7A—

7B Activities that may be treated as payment

For the Act, section 23B(1)(c)—

- (a) each class of penalty notice specified in the table to Schedule 1 is a class of penalty notice for which an activity may be completed instead of payment for the amount specified in the penalty notice, and
- (b) the activity that may be completed instead of payment for the amount specified in the penalty notice is the activity prescribed opposite the class of penalty notice.
